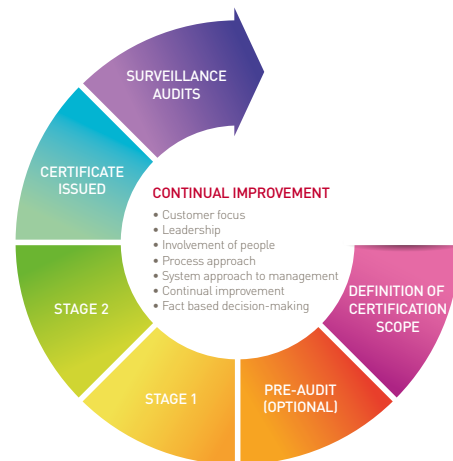

Our transition audit is dedicated to transitioning an already certified organization from the old version of the standard to the revised version of the same standard. During this audit conformance with the revised standard is assessed.

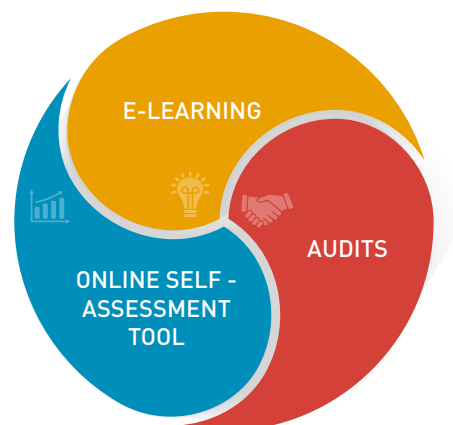
- **OPTION 1.** Recertification time. The audit will be handled like a regular recertification audit¹.
- **OPTION 2.** Next surveillance audit. Additional time will be added to assess compliance to the new requirements of the revised standard.
- **OPTION 3.** If all of the requirements of the the new version are not fully addressed you can complete the transition at the next surveillance audit, while maintaining your existing certificate.

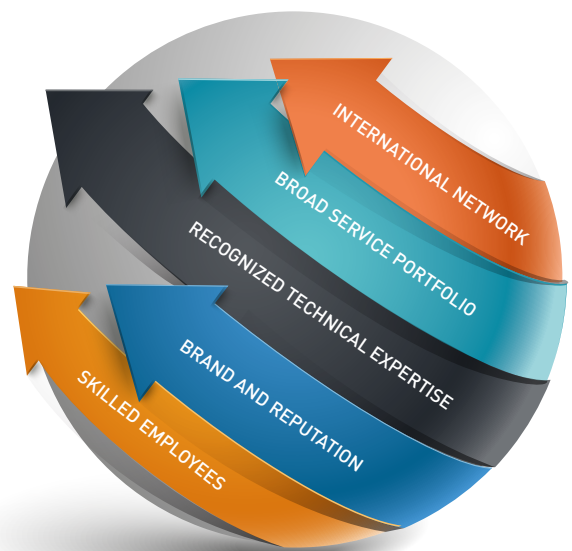
